

- 1 Business Hours April~September...9:00~18:00 October~March...9:00~17:00

We request our customers to kindly return the kickboards within business hours.

 - * Returning of kickboards after business hours (nighttime) is still available for an additional charge.

There won't be staffs after business hours so we will explain how to put the kickboards back properly.
- 2 Rental Fee Refer to the attached list of prices.

Payment must be paid in advance. Prices vary according to the type of vehicle and the amount of time the vehicle is used.

If the customer wants to use the vehicles for an extended time, please contact us by telephone before the original scheduled time of returning.

Please pay the extra charge when you return.

In addition, refunds will not be made when the customer returns the vehicle earlier than the scheduled return time.
- 3 How to Rent Any Japanese or international driver's license is required when driving a vehicle that exceeds 20km/h. Please present your driver's license for us to copy. A driver's license is not required to drive a vehicle with a speed of 20 km/h or less (16 years old or older). We will ask you to present your identification (driver's license, student ID, passport, etc.) for us to copy.

Please fill out the necessary items on the "Rental Application Form".

 - * Please fill in the contact information such as a mobile phone number that can be always contacted during the rental period.
- 4 Return Location Please return the vehicle to the place where you borrowed it. (Addr. 105 One and Only Shonan Building, 1-12-3 Katase Kaigan, Fujisawa City)

If the bicycle is abandoned at a location other than the address mentioned above, the full cost of transporting the vehicle will be charged.
- 5 Prohibited acts

 - ① Violating traffic laws such as the Road Traffic Act
 - ② Driving in a dangerous or inappropriate place
 - ③ Leaving the vehicle in some places other than the designated return location
 - ④ Continuing to ride even in the event of a breakdown leading to an accident
 - ⑤ Modification or scratching of rental items (electric kickboards, keys, helmets, accessories, etc.)
 - ⑥ Lending or transferring of rental items (electric kickboards, keys, helmets, accessories, etc.) to a third party.
 - * It cannot be used for various tests, competitions such as circuits, or in places other than roads such as coasts, riverbeds, and forests.
- 6 Violation liability Observe the Road Traffic Law and try to drive safely.

If you commit a parking violation or other traffic violation during the period of use, please promptly appear at the police station and pay the fine. (Please present the payment slip for penalties, etc. upon arrival at our rental shop.)

Please note that in the unlikely event that you commit a traffic violation while using our vehicle, our shop is held responsible for the violation and we will need to pay a violation fee, etc. You will then be required to pay us back the equivalent amount of expenses incurred by our shop.
- 7 Compensation for damages During the period of usage of the vehicle, the client will be responsible for the management of the vehicle. Another individual driving other than the client will not be subjected to compensation or compensation of damages, and the client will bear the full cost.

Regardless of the negligence of a third party, the client will be responsible for the actual cost of the damage.

If you lose or damage rental items (vehicles, keys, helmets, chargers, etc.), you will be responsible for the repurchase or repair costs.

 - * Charges for damage or loss of parts (example)

(100,000 yen per vehicle in case of theft)

Blinker: ¥3,900 / Accel throttle: ¥8,000 / Key lock unit: ¥5,000 / Horn switch: ¥4,200 / Tail lamp: ¥14,000 / Charger: ¥6,000 / Helmet: ¥3,000

In addition, if you become unable to ride due to a puncture or breakdown during the rental period, please stop driving immediately and have it repaired at your own expense at the nearest bicycle shop.

 - * Regarding waterproofing

There is no problem in normal rain, but if there is extremely heavy rain, if the internal electrical circuit gets wet due to artificial splashing of water, or if the road is flooded, it may malfunction. Please refrain from driving or leaving it in the rain for long periods of time.

In the event of a failure, the customer will be responsible for the cost of repair or repurchase.
- 8 Accident Liability The vehicle is covered by compulsory automobile liability insurance, and insurance claims are paid based on the payment standards of compulsory automobile liability insurance and only used for accidents resulting in injury or death.

If an accident occurs during the rental period, please follow the procedures stipulated by law and immediately contact the police and our rental store. The client is responsible for the settlement of the accident, etc. We do not take any responsibility for accidents.

In addition, regardless of the above, we will claim responsibility for any damages which we may suffer, including cases where we have inevitably incurred damages from third parties.
- 9 Personal Information We will use your personal information only for this rental vehicle service.
- 10 Others Please observe the rules mentioned above, and make sure to follow all traffic rules and manners.
